I. CALL TO ORDER / ROLL CALL

Meeting was called to order at 6:00 PM by George.

- B. Approval of Minutes from January Regular Board Meeting.
 - ▶ Motion by Zanini to approve meeting minutes. Seconded by Rego. Motion carried.
- C. Approval of February Agenda.
 - ▶ Motion by Lee to approve agenda with the following changes: Add to V. Old Business, A. Fire Code tabled to next meeting. Seconded by Zanini. Motion carried.

III. CHIEF'S REPORT

- A. Fire Incidents: Cornilsen reviewed the January *Monthly Fire and EMS Major Incident Report.* Of note: there were a total of 125 calls; 13 calls to the unprotected area.
- B. Response Times: Cornilsen reviewed the January *Average Response Time Per Station Report*. Cornilsen noted that the unprotected area calls are skewing response times and he will start separating calls into in-district and out-of-district response times.
- C. Training: no report this month.
- D. Equipment Status: There are issues with the chassis delivery on order for the new engine. Completion of apparatus now estimated for November or December.

 - January County Reports reviewed.
 - January Payables equaled \$171,350.36.
 - Mountain House CSD Payments all payments have been received through December. Awaiting January invoice payment.

 - 84 applications were received. Of those, we are reviewing 13 firefighter candidates and one Lt. candidate. There are currently 4 positions open and 3 more potentially.

 Association requesting new pay rates and rank structure. Administration is in the
 process of reviewing the requests.

 - ▶ Motion by Lee to place E11-2 on surplus status for 30 days at highest bid. Seconded by Rego. Motion carried.
