3. CHIEF'S REPORT

A. Chief Cornilsen reviewed Incidents and Response Times for December. He highlighted the multiple vehicle accidents in the unprotected area along Hwy 4 and multiple false fire alarms due to rain. In his review of annual statistics, he noted an increase of approximately 10% in calls from 2024 to 2025. 2024 had 1,375 calls. 2025 had 1,510 calls.
